Use case 7 Fast Track

Prequalification & Auction processes

15.03.2021





This document provides different fictive examples, so-called use cases, related to the Capacity Remuneration Mechanism being developed in Belgium. It has, as sole purpose, to explain the Functioning Rules and the functioning of the CRM IT Interface by means of examples.

The use cases developed in this document are based on the chapters **Prequalification Process** & **Auction Process** of the Functioning Rules of the Capacity Remuneration Mechanism published in **November 2020**.

By no means, the use cases replace the rules in the relevant Laws, Royal Decrees, and regulatory approved documents.


The choices in the examples are only made for **illustrative** purposes and do not imply any judgement. All the figures and numbers used for these use cases are purely fictive. These numbers nor the use cases presented should be interpreted as representing a concrete case or a concrete situation of the Belgian capacity market or an implied proposal for any CRM parameter. The **timings** and the dates represented in the use cases are **not realistic**.

The **tool** is **still under construction**. Therefore, the wording used in the presented screenshots is not definitive (phrasing to review, errors in the use of capital letters, etc.) and some fields are still missing or erroneous. As announced in TF CRM of March 2, 2021, the submitted version of **Functioning Rules** is still being **challenged** by the CREG. This might also lead to minor changes in the Functioning Rules and therefore the CRM IT interface.

In addition to these theoretic use cases, the CRM Candidate is invited to train itself via the **demo platforms** where he will be able to develop tailored use cases in the prequalification **test** module and the auction test module.




