## 5. Design product R3 down

Thibaut Gérard presents the R3 down product design, its products characteristics and concludes with next steps.

EDF Luminus demands whether the existing availability control for R3 (continuous availability control based on 15' metering) will continue to exist on top of the ad-hoc availability testing as proposed in the design for R3 down.
Elia replies that the existing availability control will be replaced by ad-hoc availability testing in the future and thus the same logic will be applied for both P1(and P2 down).

## 8. Datahub FDM – document

Wouter Notteboom presents the technical specifications for the communication of 'transfer of energy' volumes with commercial parties (suppliers and FSP's) in the context of financial compensation between the parties.

 YUSO demands whether smart meters can also be integrated in the existing settlement procedure, where currently only AMR meters are taken into account. YUSO insists on the importance to take the opportunity to open up the settlement procedure for smart meters, considered the expected evolution and the planned roll-out on the distribution grid.

Sibelga responds that currently MIG 4 does not support this option for smart meters. With the expected evolution towards MIG 6 smart meters will be taken into account.

Synergrid adds that the scope of this TDSO Datahub project is limited to the mFRR market and the publications linked to those market situations with a transfer of energy.
