



(Re)Introduction to Faster Settlement



Introduction to faster Settlement for BSP



Faster processes for the Renumeration of settlement reporting for FCR, aFRR and mFRR

- Remuneration of awarded capacity (2025)
- Remuneration of activations (not applicable for FCR) (2025)
- Penalties for availability/obligation control (mid 2026)
- Penalties for activations control (mid 2026)

Proposed improvements

- An accelerated calculation and provision of the settlement reportings to the BSP (at the latest end M+1)
- The publication of the settlement reportings and invoices on a unique communication platform (= EPIC)
- The switch from traditional billing process to a self-billing process (i.e. self-bills for remuneration and invoices for penalties)
- The provision of settlement and metering data to BSPs via API's through the EPIC platform



Introduction to EPIC






What is the EPIC platform?

- It is the abbreviation for Elia Portal Interface for Customers
- It has the ambition to merge and provide the best of the service Elia can offer into one single
 application in order to provide a 360° view of your company while avoiding redundant accounts
- It offers our clients the possibility to manage and handle their own company information and grant access to others











- All functionality previously available in the SettlementUI will be made available in EPIC
 - o For aFRR,mFRR & FCR
- SettlementUI will remain live alongside EPIC for the foreseen future
 - Phaseout of SettlementUI will be planned
- Self billing functionality will only be available in EPIC








• When navigating to the *Settlement* tab in EPIC you will be presented with your familiar summary screen of your balancing services:

- •This view can be changed to with the dropdown:
 - OA summary of the past 6 months
 - oA summary of the past 12 months
 - OA summary of the 12 months of a different year







• For each month and each service, the total settlement data is displayed in a colour that reflects its completeness:

o Red: No data available

Yellow: Partial data available

o Green: Full month data is made available & approved by Elia












- In this screen you see a more detailed level breakdown for that month

The 4 hour breakdown view looks as follows:



 - o A comment made by Elia can be seen in the *Elia Comment* column






- If you want to give a comment to Elia, you can do so by clicking the '+' and selecting that row

 - On't forget to click the 'update'!








End to end Settlement Flow



Notification & Data Review



- BSPs receive email notifications when new settlement data is published, including details on what's available
- BSPs should review settlement data directly in EPIC
 - Data will also be available through TraXes API's as explained in the previous workshop



Approval & Self-Billing



- BSPs must approve settlement calculations directly in EPIC if they agree with the data
 - Ability to disapprove in case of a dispute
- Once approved, self-billing is automatically initiated
 - Depending on a positive or negative amount:
 - Self bill on behalf of BSP created
 - Invoice for the BSP created
- BSPs receive an email notification when the bill is generated
- This self billing accelerates the process, eliminating the need for manual bill creation by BSPs

Disagreement & Comments



- BSPs can disagree with calculations and leave comments directly in EPIC
- Elia will review the feedback and will try to resolve any issues
- If updated settlement data is reuploaded, the BSP will receive another email notification and the approval process it restarted
 - o It's possible the BSP once again disagrees

Deadlines & T&C


- The terms & conditions are still up for approval with the CREG, so the next items are pending approval!
- After settlement data is uploaded, BSPs have 25 days to approve or disapprove, as outlined in the new T&C
- If no action is taken within 25 days, implicit approval is assumed and the billing process will be launched
 - o If the self-bill is launched after the 25 days, but the BSP finds an error in their data, Elia will still try to resolve these issues and reach an amicable agreement with the BSP
 - In this scenario a credit note will be sent to rectify the situation



Invoices in EPIC




- The payment terms of these self-bills, invoices and credit notes is now 15 days, down from the previous 30 days
- All financial documents are available directly in EPIC
- BSPs can easily sort, view and download bills
- Invoice type indicates the type of bill:
 - Provision = Initial bill
 - Delta = Correction bill
- You can filter on both "Product Type (BSP)" & "Contract Name" (i.e., aFRR, FCR or mFRR)
- No need to switch platforms or manage emails for invoice retrieval (Centralized access)
- Improves transparency and simplifies record-keeping for all settlement-related financial documents






Final remarks





Practicalities

- All functionalities are available via EPIC
 - Also available through Traxes API's (last week's training)
- We plan to also release screens for controlling (penalty) services to EPIC
 - In accordance to the roadmap, self billing for control will not be available before Q2 2026

BSP Readiness

- 1. Know your way around EPIC (you will receive a notification mail, no longer reports via mail)
- 2. Make sure to be ready for self-billing on your side (you will no longer need to send invoices)
- 3. Assure the shortened payment deadlines can be met (=15 days following the receival of billing documents)
- 4. Check compliance via PEPPOL platform to receive and send e-invoices (registration on Peppol Network)
- 5. Let us know if you want to create your own tooling (using TraXes APIs)

- → Your KAMs will contact you to ensure readiness
