Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 22,149 Elia Group shares during the period between between 6 September 2021 and 10 September 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 16,599 Elia Group shares.
