Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 22,431 Elia Group shares during the period between between 13 September 2021 and 17 September 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 18,378 Elia Group shares.
