Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 7,061 Elia Group shares during the period between between 29 November 2021 and 3 December 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 6,646 Elia Group shares.
