Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 12,800 Elia Group shares during the period between between 31 January 2022 and 4 February 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 7,709 Elia Group shares.
