Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 2,050 Elia Group shares during the period between 31 October 2022 and 4 November 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 2,520 Elia Group shares.
